Analysis of the Royal Commission's recommendations regarding staffing hours

Background

The Royal Commission highlighted the changing needs and expectations of residents impacting on **staffing attributes and skill levels**.

The expansion of home care internationally has resulted in people entering residential aged care with greater **complexity of care** needs, demanding **greater flexibility**, more **choice**, more **autonomy** and a **higher quality** of services.

Together with the shift towards person-centred care, these changes require a staffing profile that can support 'resident' **autonomy** while addressing clinical needs associated with **complex health** care needs and co-morbidities





Senior Counsel assisting the Royal Commission initially recommended adopting the American CMS star rating system and a minimum for allied health care.

The proposal includes -

- Achieving a 4-star rating under an adjusted US staffing model
- > A minimum of 30-63 minutes of RN per resident per day
- An average case mixed total of 3.1 4.4 care hours per day (RN,EN,PCWs)
- > A minimum of 22 minutes of allied health per resident per day
- Industry concerns were raised this proposal could send residential aged care backwards



Final Report – Feb 2021

The final report did not include the star rating model. Instead it recommended the amount of daily care and registered nurse time required and no mention of allied health.

1 July 2022 (3.3 hours)

- Minimum of 40 minutes RN PPPD
- Minimum 160 minutes EN/PCW PPPD
- At least one RN on site per RACS for morning and evening shift (16 hours per day) 7 days a week
- > The minimum linked to a **case mix-adjusted** funding system
- Applied 'for the average resident' suggesting a CDC model similar to Home Care where Providers are required to designate / record hours with spent with each resident



Final Report – Feb 2021

1 July 2024 (3.6 hours)

- Minimum of 44 minutes RN PPPD
- Minimum 171 minutes EN/PCW PPPD
- > At least one RN on site per RACS at all times (24/7)
- Can apply for an exemption to staff mix but not hours -
 - Homeless facilities (substitute RN with other professional)
 - Multi-purpose facilities (RN/ENs are present at co-located service)
 - Regional and remote homes unable to recruit sufficient numbers of staff and or skill mix
 - Trialling an alternative skills mix (substitute RN with other professional)




ACFI = WAGES


